# GREENVILLE COUNTY ECONOMIC DEVELOPMENT CORPORATION PETITION FOR EXEMPTION FOR PARTIAL DISCONTINUANCE AND PARTIAL ABANDONMENT IN GREENVILLE COUNTY, SC

MOTION TO STRIKE PORTIONS OF GREENVILLE COUNTY ECONOMIC DEVELOPMENT CORPORATION'S REPLY AND EVIDENCE IN OPPOSITION TO WESTERN CAROLINA RAILWAY SERVICE CORPORATION'S REQUEST TO SET TERMS AND CONDITIONS

Pursuant to 49 CFR 1117.1, Western Carolina Railway Service Corporation ("WCRS") hereby moves to strike certain arguments in Greenville County Economic Development Corporation's ("GCEDC") Reply ("Reply") filed with the Board on February 21, 2006.

WCRS moves that the Board issue an order striking the following contradictory, erroneous, unsubstantiated and misleading information contained in the Reply on the basis explained following each item listed:

#### Exhibit 1 – Verified Statement of Gerald W. Fauth, III

- a. <u>Includes</u> three trestles totaling 170 feet at MP 0.86, MP 4.09, and MP 11.45 that <u>do not exist</u>. (*Table 3, Fauth, pp. 8*)
- b. Excludes one previously documented trestle totaling 420 feet at MP 1.74. (Exhibit B, Slide 14, WCRS Request for Establishment of Terms and Conditions filed February 14, 2006) and (Exhibit 9, Pettry, pp. 3, GCEDC Petition For Exemption For Partial Discontinuance and Partial Abandonment in Greenville County, SC filed June 24, 2005) and (Exhibit 10, Hoff, pp. 2, GCEDC Reply to Complainant's Opening Statement in STB Docket No. 42087 filed January 24, 2005)

#### 2. Exhibit 2 - Verified Statement of Charles E. McDonald, Jr., Esquire

GCEDC's interpretation that it holds fee simple title (*McDonald*, *pp*. 3-7) is inaccurate in that it spends no time discussing the nature of that deed of conveyance by which GCEDC was conveyed title to the line in 1999 (*McDonald*, *pp*. 44-48), nor does the exhibit include or mention GCEDC's own title insurance policy, which insures the line as "Easement" only (*Exhibit D*, *pp*. 83-90, *WCRS Offer of Financial Assistance filed October 3*, 2005).

#### 3. Exhibit 3 - Real Estate Appraisal of Mark B. Ratchford, MAI, SRA

That appraisal which comprises Exhibit 3 is inaccurate in that it was calculated using an assumed fee simple interest interpretation which is contrary to that deed of conveyance (mentioned in Item 2, above) by which GCEDC was conveyed title to the line in 1999. Consequently, it should be stricken or, alternatively, properly evaluated by the Board to determine an accurate market value.

#### 4. Exhibit 4 - Verified Statement of Andrew J. White, Jr., Esquire

Mr. White's verified statement (*White, pp. 1-7*) should be stricken because it goes to great length explaining GCEDC's alleged S1.3 million total purchase cost for both the Northern Segment and the Southern Segment, as well as the alleged combined values, without separating those actual and real expenses it assigns to each segment. Because the Southern Segment is not the subject of the pending Offer of Financial Assistance ("OFA"), and because those costs are not deducted from the alleged total, it is not possible to arrive at any specific or beneficial value that was assigned to the Northern Segment or that would be applicable in this OFA.

WCRS urges the Board to strike the aforementioned items from the docket.
